Footloose Terms and Conditions

When you join Footloose, we want to ensure that you are completely satisfied with all aspects. Below are our terms and conditions which let you know what to expect from us and what we expect from you.

Parent/Guardians Responsibility

We ask parents/guardians of children under 6 years old to remain on site whilst their child is participating in a class. We also ask that once a child reaches the age of 12, parents/guardians wait outside of dance space. For Saturday classes, we ask that if a child has longer that 30 minutes to wait between classes, the child is collected for that break and returned when the next class starts. Children NOT participating in our classes but left unattended cannot be the responsibility of Footloose School of Dance.

Arrival and Departures

We ask that all parents/guardians ensure that children arrive on time for classes as being late affects the other children in the class and ultimately affects you own child's learning. No child will be able to leave the premises without a parent or guardian unless written notification is received. If any emergency occurs and you are running late or cannot collect your child, please ensure you notify another parent or teaching staff so arrangements can be made.

Medical Conditions and First Aid

It is your responsibility to inform us of any pre-existing medical conditions (including allergies), physical challenges or behavioural conditions. If your child has any medication requirements whilst in our care, we can arrange provisions for the child's specific needs.

First aid will be administered to all children that need it. All accidents will be recorded appropriately and if serious, we may call the emergency services.
